THE YRC IS STAFFED BY PROFESSIONAL STAFF AND VOLUNTEERS AVAILABLE TO PROVIDE EMOTIONAL SUPPORT AND CONNECT YOUTH AND FAMILIES WITH RESOURCES AND REFERRALS. THE BRIDGE ALSO HOSTS YSNMN.ORG, A MOBILE APP ALLOWING YOUTH TO SEARCH FOR AND CONNECT WITH AVAILABLE SHELTER AND RESOURCES AT 53 LOCAL AND NATIONAL ORGANIZATIONS SERVING MINNESOTA YOUTH.
